

FOSTER CARER PAYMENTS AND ALLOWANCES

We are delighted to present our updated payments and allowances for 2025/26.

At Leicestershire County council, we understand that people foster because they care, and they want to make a difference to Leicestershire's' children and young people in care.

However, we also understand that it is vital that our carers receive payment for their skills, efforts and work with us – we all have bills to pay!

Our payment levels enable our carers to progress, with our support and guidance and receive fair payment for their vital roles.

As members of The Fostering Network, our carers will also have access to offers and reductions including mortgage deals, house insurance offers and reduced admittance to theme parks.

We also believe that payment is not just about the money. It is vital that our carers are supported in their role. This is why every carer will have their own supervising social worker, access to support 24/7 and our dedicated support team – who offer additional support to carers as well as our very popular annual Foster carer's awards events and foster carer fun days throughout the year.

Most foster carers do not have to pay income tax on their earnings. They will receive a tax-free allowance of **£19,690** and an additional weekly allowance based on the child or young person. As you will see below, there are many other ways that Leicestershire County Council supports you to look after our children for example, uniform and clothing allowances as well as our birthday allowance to ensure our children and young people get to enjoy their special days too.

Weekly Fostering Allowance:

The weekly fostering allowance is the amount that is paid to foster carers whilst they have a child in their care and does not include the skills fee that they are paid in addition to this. These rates are **free from income tax**, as long as they do not exceed the qualifying amount.

+ Your skills Fee:

The skills fee is an amount paid on top of the fostering allowance to recognise the carers' skills, experience, learning and development. All mainstream foster carers will start on level 1 and will progress through the levels when they have met the competencies, training and development requirements for each level.

Other Allowances

1. Set up allowance

An allowance of **£362.00** is available to all newly approved foster carers to help with getting the basics ready for their fostering role.

2. Clothing Allowance

In cases where children or young people arrive in an emergency with no clothing, or inadequate clothing, a payment of **up to £191.80** for each child can be made direct to the foster carer.

3. School Uniform Allowance

The department provides additional help with school uniform when:

- A child starts primary school (when a grant of £134.10 is paid).
- A child changes school (the grant will depend on what clothing the child already has and what they need for the new school).
- A child starts secondary education (a grant of £191.80 is paid).

4. Birthday Allowance

The Birthday Allowance is equal to one week's Fostering Allowance and is paid automatically just before the child's birthday for gifts and celebrations.

5. Festival Allowance

The Festival Allowance is equal to one week's Fostering Allowance and is paid automatically at the beginning of December. If you would like it to be paid instead for another major religious festival please let your supervising social worker know.

6. Holiday Allowance

These payments are age-related and are based on two weeks of the basic fostering allowance. Payments will not be made automatically, but will have to be claimed by foster carers at the appropriate time.

7. School Trips Abroad

Educational trips for children are important for their development and consideration should be given to a number of possible funding sources including pupil premiums, a child's Personal Education Allowance (PEA), corporate parenting team and fostering allowances that carers receive, including the holiday allowance.

Specialist Level Care

1. One2One / Aspire carers

Retainer fee of £847.30 per week when there is not a child placed, and the age-related fostering allowance is paid in addition while a child is living with you.

2. Pathway Carers

Carers are paid £566.30 per week that a child is living with you plus the fostering allowance.

3. Short Breaks

There are two levels of short break carers which reflect the complexity of the child or young person's disability and care needs:

4. Parent & Child

Parent & child carers will receive a mainstream level 3 payment including the national minimum age related allowance for the child. The carer will also receive a fee of £560.30 for the adult. Additional parent in placement will be paid at a flat rate of £272.00 per week.

5. Bridging carers

Bridging carers are paid £487.00 per week in addition to the fostering allowance for the child based on their age, while a child in living with them.

6. Supported Lodging Hosts

SLPs are paid £317.10 per week when a young person is living with them.

7. Supported Lodgings Plus Hosts

SLP+ Hosts are paid £622.50 per week, plus mileage when a young person is living with them.

8. Staying Put

Staying Put carers are paid £317.10 per week when the young person is living with them.

9. IFA & OLA Transfers

After an initial visit has been carried out to establish the needs of any children in potential carers' care and their suitability to foster with LCC, an individual offer will be made to potential carers.
