

#### PROPOSED 20MPH AND 50MPH SPEED LIMITS

#### **STATEMENT OF REASONS**

The Leicestershire County Council (LCC) is proposing to introduce a 20mph and a 50mph speed limit on Main Street and The Avenue in the village of Shangton.

There has been a request made by Shangton Parish Meeting for a reduction of the speed

Assessments have shown that the roads in the village of Shangton are conducive to a

Additionally, the Police have recommended to make the speed limits on Main Street and The Avenue consistent with the B6047 Melton Road. Leicestershire County Council proposes to reduce the speed limit on these roads that are not part of the village 20mph from national speed limit to 50mph.

The order is being introduced to improve road safety.

- This Order may be cited as "The Leicestershire County Council (Various Roads, Shangton, District of Harborough) (Imposition of 20mph and 50 mph Speed Limits)
   Order 202 "
- 2. The Order shall come into force on the day of 202
- No person shall drive any motor vehicle at a speed exceeding 20 MPH on the lengths of roads as specified in Schedule 1 to this Order.
- 4. No person shall drive any motor vehicle at a speed exceeding 50 MPH on the lengths of roads as specified in Schedule 2 to this Order.
- The plan annexed to this Order and marked drawing number TM5144/T1/1 is for identification purposes only.

#### SCHEDULE 1

#### IMPOSITION OF 20 MPH SPEED LIMIT

#### In the Parish of Shangton

#### Main Street

From a point 285 metres west of its junction with The Avenue, Shangton to a point 150 metres east of its junction with The Avenue, Shangton

#### The Avenue

From its junction with Main Street, Shangton to a point 230 metres south of its junction with Main Street, Shangton

#### IMPOSITION OF 50 MPH SPEED LIMIT

#### Main Street

From a point 150 metres east of its junction with The Avenue, Shangton to its junction with the B6047 Melton Road, Shangton

#### The Avenue

From a point 230 metres south of its junction with Main Street, Shangton to its junction with the B6047 Melton Road, Shangton
