The comments made on behalf of our clients relate to Plan 5 and 5A of the plan folio dated 29<sup>th</sup> July 2020.

Extracts of these plans are attached for clarification.

Marked in red, on each plan is a new private means of agricultural access. This means access is required as the existing access is severed by the route of the new road.

The details of this access were discussed and agreed with Leicestershire County Council ([REDACTED]) on 15<sup>th</sup> July 2019.

The agreed agricultural access has been omitted from the Side Roads Order.

The agreed specification for the access is: A pair of 4m metal gates giving a total opening width of 8 metres.

A concrete area leading from the tarmac edge of Lag Lane into the field.

Please confirm that this omission from the Side Roads Order will be rectified. To ensure that our clients is not without access as a result of the Distributor Road.
