I write to thank you for your written comments on behalf of BB & B Leisure Parks Ltd. dated the 18th November 2020 which have been forwarded to me, as the Promoter's representative, by the Department of Transport following your objection to the above identified Orders.

I note from your written comments that you have raised a matter of concern in respect of the Leicestershire County Council's proposal to bring forward a bypass to Melton Mowbray. The Scheme itself, which we have called the North and East Melton Mowbray Distributor Road (NEMMDR) is intended to enable through traffic to avoid passing through the town and to enable additional residential development to take place to meet the identified needs.

I wish to take this opportunity to address the matter which has been raised in your letter so that your client can understand the Council's position in respect of them. We would hope that your client would then be able to reconsider the matters have been raised, to see if you would wish to present them as objections to the Public Inquiry, which will be held later this year.

- 1. BB & B Leisure is the owner and operator of the Twinlakes Park and is keen to maintain access to the Park throughout construction.
- 1.1 At the meeting on the 11<sup>th</sup> September 2019 a representative of the Scheme's contractor demonstrated how Twinlakes Park access could be kept open throughout the construction period. The proposal around construction phase accesses is still under development and is subject to approvals but LCC maintains this principle of continued public access to the park throughout the construction phase and would be happy to clarify the proposals further when we next meet if that is required.
